Louise Russert-Kraemer

The sad news is that Louise Russert-Kraemer died February 13, 2009.

She was in Cleveland with her daughter, Lisa, when she had a stroke and never recovered. Louise was serving as president of the League of Women Voters of Washington County until Mid-December, when she resigned because of ill health.

Louise was a dynamic person with a strong personality who never stopped questioning and learning. She was a compassionate person who cared deeply for her students, her friends and for many "good causes," particularly those protecting the environment. Her impact on both the University of Arkansas and on Fayetteville was great.

Louise's devotion to her family, and theirs to her, was reflected by the fact that 18 of her children, grandchildren and their spouses were present at her memorial service. She is greatly missed.

Programs and Policies

The League will consider changes to its *Program for Action* on Wednesday, March 18, 2009 at 6:00 p.m. This annual event will be hosted by Karen Rollet-Crocker and is a chance for League members to discuss our policy stands in light of the information gleaned during the year's programs or changing circumstances. Everyone should take some time to review the current *Program for Action*, which is available on the League website www.lwvarwc.org, and come prepared with suggested changes. A transportation study group recommended the following additions during a December meeting after reading the University of Arkansas Community Design Center's study on light rail in Northwest Arkansas, the 2030 Regional Transportation Plan and an article describing the newly formed Regional Mobility Authority. Changes to the section on Public Transportation are in bold.

- I. Public Transportation
(1988, 2006)

The LWVC supports coordinated public transportation service **such as light rail** in Washington County with the following provisions:

1. Continuous participation by business industry, labor and civic, governmental, and other institutions in the planning, development and operation of coordinated public transportation;
2. Cooperation among government and private entities for the purpose of regional solutions;
3. Use of **adequate** public and private funds to subsidize public transportation;
4. All planned phases of public transportation should weight the social and environmental as well as economic considerations.
5. **The Regional Mobility Authority should dedicate a portion of their funding to alternative transportation options.**

Members will have the opportunity to discuss this proposal as well as any other suggestions before reaching a consensus on what should be presented for formal approval at the Annual Meeting in May. Come share policy talk, wine and light refreshments with your fellow League members.
