

Absentee Voting to be Allowed in Arkansas

Governor Asa Hutchinson announced last week that anybody in Arkansas could vote by absentee ballot in the November elections if they have a health concern related to COVID-19. You can request an absentee ballot from your [county clerk](#) before October 27. Ballots must be submitted by 7:30 pm on Election Day with a photocopy of our state ID. If you are not registered, fill out this [registration form](#) first, and return it to your [County Clerk](#).



Arkansas First Signature Success
[Arkansas First](#) and the League of Women Voters gathered over 100,000 signatures from registered Arkansas voters in support of our measure to end gerrymandering in Arkansas. These signatures more than satisfy the state's requirements to get our constitutional amendment on the ballot.

Report on the Annual Meeting

Dr. Janine Perry, Professor of Political Science at the University of Arkansas, [Director of the Arkansas Poll](#), and author of [Women's Rights in the USA](#) and [Readings in Arkansas Politics and Government](#), was the keynote speaker at this year's Annual Meeting. She discussed the history of absentee balloting, its successes, and the current controversy surrounding it. She also addressed Arkansas recent decision to permit absentee voting because of the pandemic.
