A very important meeting for all League Members will be held in the Pat Walker Auditorium Senior Center (WRMC) on Wednesday, November 16, 6:30—8:00 p.m. At this meeting, we will help the LWVUS establish a position on "The Role of the Federal Government in Public Education."

The October 2011 *VOTER*, pages 5-6 (<http://www.lwvarwc.org/newsletter/2011oct.pdf>), contained the questions we will answer as we reach a consensus to express our group opinion. Our answers along with all other Leagues will be forwarded to the National office and will be used to form a position to guide the League as it advocates for or against proposed legislation on education.

The presence and opinion of every League member is vital for this process to be successful.

LWVWC Legislative Luncheon Tops Previous Attendance

A 70% participation of Washington County Legislators and a 50% increase in luncheon attendance over last year provided a very lively discussion of upcoming state issues and economic challenges. As noted previously in the "From the President" article, Mary Alice Serafini posed questions on and moderated legislators' responses to topics ranging from health care and Dream Act scholarships to the highway funding tax election. Audience members initiated discussions on additional issues of poverty, motorcycle helmet law, teen pregnancy, wage theft, and alternative transportation in Arkansas. The legislators expressed concerns about budget limitations, substance abuse, taxation, and prisons. They also expressed interest in seeing that the budget session beginning in January, 2012, is tightly run and concludes in a timely fashion. Several bills were discussed that had not made it out of committee in 2011 and their sponsors are planning to re-introduce them in 2013.

A reception is scheduled for Monday, November 14, 2011 from 5:30 to 7:30 PM to celebrate the release of a Winthrop Rockefeller Foundation “PARTNERS IN PROGRESS” report, entitled "*Arkansas Advocates for Children and Families: Affecting Policy and Programming.*"

The Winthrop Rockefeller Foundation (WRF) has been one of AACF’s primary partners since the AACF’s inception. WRF support has enabled AACF to respond to emerging public policy issues affecting the state’s most vulnerable children and families over the past four decades. WRF has devoted the second edition of its Partners in Progress series to examining this partnership. The series was developed to share lessons learned and to provide documentation that gives all stakeholders—not just grantees—the opportunity to reflect on their ability to impact, influence, and leverage resources for positive change in Arkansas.

Remembering Ernie Deane at the Shiloh Museum

Journalist, educator, and historian Ernie Deane will be remembered in a program by his daughter, Frances "Fran" Deane Alexander, at noon on Wednesday, November 16 at the Shiloh Museum of Ozark History.

The program is presented in conjunction with the museum’s newest exhibit, “Whatever You Do, Stay in Print: The Life of Ernie Deane,” which opened on October 3, 2011 and will be on display until July 21, 2012.

Ernie Deane was a press officer for Lieutenant General Omar Bradley, General Dwight Eisenhower, and General George S. Patton during World War II and at the Nuremberg Trials after the war; a newspaper columnist and author of “The Arkansas Traveler” and “Ozarks Country”; a professor of journalism at the University of Arkansas; a director of the War Eagle Fair;

a champion of historic preservation and a key figure in rallying support for restoring Old Main; and a community activist.

The Shiloh Museum, located at 118 W. Johnson St. in Springdale, is open Monday through Saturday and admission is free. For more information, call 750-8165.

Dr. Douglas Reed is Moody Professor of Political Science and Margaret is Associate Professor and Media Librarian.

Government in Arkansas is an approved textbook for use in Arkansas schools and has been a helpful reference to some newly elected state legislators. We are also fortunate to have Dr. Ethel Simpson, retired from the University of Arkansas’ Special Collections Department, voluntarily contribute her editing skills.

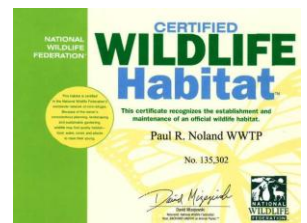

Fayetteville Community Wildlife Habitat Project Resident Registration Count-Down

Fayetteville residents are on track to help our city become the first in Arkansas to be certified for the high quality of its urban habitat for wildlife. Less than 50 more applications are needed by the December 31, 2011 Registration Target Date, in order to meet the National Wildlife Federation Community Wildlife Habitat Project Residential Criteria requiring the participation and approval of at least 200 homes/yards in the city (NWF Garden for Wildlife Link: <http://www.nwf.org/Get-Outside/Outdoor-Activities/Garden-for-Wildlife.aspx>).
