A Comment from the LWVWC President – Joyce Hale



With three quarters of the League year calendar completed, the LWVWC is proud to claim an impressive increase in new members and renewals, record attendance for hot issue programs and the successful introduction of Drinks and Dialogue topics. In the last quarter, our focus will change to internal management of the League at all three levels: local Annual Meeting, LWVAR Council, LWVUS National Convention, and participation in the Citizens First Congress Convention.

At each of these activities members see first hand the potential the League of Women Voters brings to education on public policy. New members particularly benefit when gaining a better understanding of where they can fit into the organization.

LWVWC will continue to focus on voter registration and suppression concerns. If the petition for independent redistricting is approved, we will support signature gathering. Whether there is a change in how 2021’s district map lines are drawn or not, an informed public will be needed to act as watch dogs of the process.

We invite individuals and other organizations concerned about the integrity of our elections and increased voter participation to join with us. You are invited to hear guest speaker, Maddie Spickard, Executive Assistant & Communication Specialist from the Women's Foundation of Arkansas. She will give an overview of the study, "Economic Indicators for Women in Arkansas: State, Region, and County". To be publicly released on March 30, 2018, the WFA's new benchmark study highlights the status of women across our State. It focuses on economic indicators such as poverty level, health insurance, education, earnings, wealth attainment, and more.

Equal Pay Day is the symbolic day when women's earnings "catch up" to men's earnings from the previous year. It's also a powerful occasion to raise awareness about and organize action around the gender pay gap in your community.

The gender pay gap is the difference between what men and women typically are paid. Research shows that across demographics and workplaces women are consistently paid less than men in the United States and around the world.



Update on Independent Citizens Redistricting Commission



Interest in redistricting was evident when over one hundred people came out on a rainy night February 22nd to hear Little Rock Attorney, David Couch. The meeting took place at St. Paul's Parish Hall where Couch described the petition he has prepared to establish a citizens' independent redistricting commission. If you missed attending the program, it is available on the LWVWC website in the section describing the redistricting program.

If the petition passes, it will create a constitutional change replacing the partisan controlled system by elected officials who now determine the district boundaries for congressional and legislative seats. The petition has been filed twice for approval by Attorney General Leslie Rutledge who has ruled against it both times.

Even if approved in the near future, there will be little time to secure the 85,000+ signatures needed before the July 6 deadline to appear on the November ballot. But this does not need to be the end of the story. Change sometimes comes slowly until there is a critical mass if voters who understand the importance of an issue. Other states have just begun working on this issue as well. There are collaborative efforts to bring national attention to making apportionment fairer. Most important is for voters to understand whatever system is in control the public must watchdog the process to see that maps promote fair representation and not the partisan manipulations of the past. Both parties are guilty of gerrymandering. Stay tuned and watch as the census and reapportionment bring their decennial changes.
